5. Material:

The Pro-Training Treat Pouch is made from nylon fabric with a neoprene opening.

6. Characteristics:

7. Functionality:

The Pro-Training Treat Pouch is designed to carry small treats, kibble, or balls inside the large main compartment. Overlapping neoprene panels at the top of the Treat Pouch allow the user to easily insert and remove their hand. These panels also help retain the items kept inside the Treat Pouch. A zippered front compartment can hold smaller items separately. Side webbing allows additional items to be attached to the Treat Pouch. An adjustable belt allows the user to wear the Treat Pouch around their waist. Alternatively, a belt clip allows the user to clip the Treat Pouch to their own belt or trousers.

12. Mitigation measures:

12.1 Safe material

Starmark Pro-Training Treat Pouch is made from nylon fabric and neoprene.

12.2 Durable and functional design

Starmark Pro-Training Treat Pouch is made from durable fabrics to withstand prolonged and repeated training usage and washing.

12.3 Labeling and information

Usage information is included on packaging and online.

12.4 Compliance testing

Both mechanical and live testing is conducted on all product prototypes prior to launch for safety and durability.

12.5 Risk monitoring and management

Defective products that do not meet quality standards are culled during the manufacture process.
