These training aids are designed to be used under supervision. The stainless steel clicker element produces a clear, consistent sound. Once this sound is paired with a reward, it communicates a message of "job well done" and makes desired behaviors more likely to reoccur.

12.1 Safe material

Starmark Pro-Training Clickers are made from a stainless steel clicker element housed inside a nylon body.

12.2 Durable and functional design

Starmark Pro-Training Clickers are made of a durable material to withstand prolonged and repeated training usage.
